 - Based on an emergency meeting in December, decided that students will not be going to Boston this year.
 - Funds an issue
 - Parents concerned about terrorism attacks

 - Behind the scene issues that contributed to decision
 - Discussions of homeschoolers
 - Dollar amount in account currently unknown
 - KM: Estimates around \$314
 - JC: What are the plans going forward
 - Discussions of going in 2017
 - o Have not contacted families of the 2017 group
 - JC: Suggests an event this year where students can be together in a historic event that is a cheaper venue.
 - JG: Feels strongly about keeping an event this year, and not combining.
 - AC: Feels the event was so much stronger in the past because the students learned about Boston before they went. But students are not learning about Boston as part of their regular curriculum.
 - KM: Trip current abandoned because of finances. Not possible given the timeline.
 - KM: Primary purpose of the trip needs to be education.
 - JC: Tasked Lorna with gathering the group and developing a plan for an education event this year
 - AC: Would like to see whatever they do be coordinated with the history class.
 - Discipline procedure
 - JC: If a student is put on suspension for any reason, any tests given during this time, no tests scores or homework
 - JG: Historically this policy was intended for students with "heart issues", not for students who are struggling academically. The policy would hopefully incentivize the student to perform the work within their means.
 - AF: The policy should not be a surprise to anyone.
